3. A \$100 admin fee shall be retained by APC rally if a rider withdraws prior to 4 months before a rally.

## APC RALLY TERMS AND CONDITIONS OF USE FOR THIS MAP

*Please note these terms and conditions relate to purchasing and using the map purchased.*

Please carefully read and agree to the following terms and conditions which form part of the contract you enter into by using one of our maps.

1. The map is produced by APC RALLY of 1298 Wynnum Road, Tingalpa QLD 4173.ABN 81776345062
2. A deposit is required to establish and hold a reservation. The full balance is due and payable within 90 days. Your MAP purchase will be considered cancelled should the full balance not be received by APC RALLY
3. Should you have to cancel we must receive notice in writing (email is acceptable). This must be received (14) days prior to recommended departure date. If received with less than thirty 14 days notice any refund will be solely at our discretion. In the circumstances we strongly recommend that you obtain trip cancellation insurance from an insurance company. Please note there is a \$50 admin fee charged on all cancellations.
4. You are responsible for ensuring that you are fit and healthy enough to ride the track this map marks out. We reserve the right to insist on a medical certificate from your doctor stating that you are in a suitable condition.
5. The map producer has the sole discretion to alter the itinerary should it become necessary due to weather, local conditions, politics or various other reasons. No refund will be considered in the event of any such changes.
6. APC RALLY and John Hudson take no responsibility for any flight delays or scheduled changes at any stage throughout the trip. In the event of any such change no refund will be considered.
7. APC RALLY, JLH Advertising and John Hudson insist that riders take out a personal travel insurance policy and will request proof the same. It is the rider's responsibility to ensure suitable insurance is taken out prior to commencement of the trip.
8. APC RALLY, JLH Advertising PTY LTD and John Hudson is not responsible for any accidents.
